- SUBJECT: A RESOLUTION OF THE ELK VALLEY RANCHERIA, CALIFORNIA AUTHORIZING THE CITY OF CRESCENT CITY, CALIFORNIA TO SUBMIT A JOINT GRANT APPLICATION TO THE REBUILDING AMERICAN INFRASTRUCTURE WITH SUSTAINABILITY AND EQUITY (RAISE) PROGRAM FOR THE FRONT STREET PEDESTRIAN IMPROVEMENT AND ROADWAY REVITALIZATION PROJECT AND AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO SIGN DOCUMENTS NECESSARY TO APPLY FOR RAISE FUNDING
- WHEREAS: The Elk Valley Rancheria did on November 23, 1994, adopt its Tribal Constitution and Bylaws which was approved by the Commissioner of Indian Affairs on December 27, 1994, and, by tribal law, the sovereign authority of the Tribe over the matter described herein is delegated to the Tribal Council, acting by law;
- **WHEREAS**: Article IV, Section 1 of the Constitution identifies the Tribal Council as the governing body of the Tribe;
- **WHEREAS**: Article V, Section 1 of the Constitution authorizes the Tribal Council to expend funds and to take all actions to protect and promote the interests of the Tribe;
- **WHEREAS:** The Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant program was created by Congress to provide a unique opportunity for the Department of Transportation (DOT) to provide for capital investments in surface transportation that will have a significant local or regional impact;
- **WHEREAS:** RAISE can provide capital funding directly to any public entity, including municipalities, counties, port authorities, tribal governments, MPOs, or others;





WHEREAS: The goals and objectives of the RAISE program are consistent with the Tribe's Comprehensive Transportation and Master Plan;

NOW, THEREFORE, BE IT RESOLVED: That the Tribe is an eligible applicant and is authorized to submit a joint grant application for the Front Street Pedestrian Improvement and Roadway Revitalization Project through the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant program; and

BE IF FURTHER RESOLVED: That the City of Crescent City, California City Manager, or his designee as appropriate, be authorized to sign documents necessary to apply for RAISE funding for this critical project;

BE IT FURTHER RESOLVED that the Tribal Council does hereby authorize the Chairperson of the Elk Valley Rancheria, California, or, in the Chairperson's absence, the Vice-Chairperson, to execute and deliver all other documents that are necessary to implement the intent and purpose of this Resolution.
